**Invitation to Bid for the Construction of Gymnatorium with State-of-the-Art Facilities
(Phase II) MMSU, City of Batac**

1. The **MARIANO MARCOS STATE UNIVERSITY (MMSU)** through the General Appropriations Act of 2020 intends to apply the sum of Thirty Nine Million Nine Hundred Ninety-Nine Thousand Forty Nine Pesos & 66/100 (P39,999,049.66) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Gymnatorium with State-of-the-Art Facilities (Phase II), MMSU, City of Batac. Bids in excess of the ABC will be automatically rejected.
2. The Mariano Marcos State University now invites bids for the above project. Completion of the works is required within 250 calendar days. Bidders should have completed, at least one (1) contract that is similar to the contract to be bid, and whose value, must be at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from **MMSU** and inspect the Bidding Documents at the address below anytime during work hours.
5. A complete set of Bidding Documents may be secured starting June 11, 2020 at the address below, upon payment of the corresponding fee in the amount of Twenty-Five Thousand Pesos (P25,000.00) Bid Documents may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at the website of **MMSU**, provided the corresponding Bid Fee are paid prior to the submission of the bid.



6. The **MARIANO MARCOS STATE UNIVERSITY**, will hold a Pre-Bid Conference on **June 18, 2020, at 2:00 PM**. At the Conference Room, FEM Hall-Extension, MMSU, City of Batac, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **2:00 PM, July 2, 2020**, including a bid security in any of the acceptable forms and in the amount stated in Clause 18.
Bid opening shall be on **July 2, 2020 2:00 PM** at *the Conference Room, FEM Hall, MMSU City of Batac*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. MMSU reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
